Membership Agreement

(Individual or Joint)

Application is hereby made for membership in the GREENWOOD CREDIT UNION, (hereinafter referred to as "GCU"). The applicant(s) hereinafter referred to as (WE) agree to be bounded by the by-laws of GCU and all subsequent amendments thereto. We further agree as follows:

- 1.) This agreement only covers the subaccount(s) opened under and designated by the Member Number on the signature card hereinafter referred to as (this Member Number).
- 2.) GCU may recognize any one or more of the authorized signatures for this Member Number as joint owners of the subaccount(s) entitled to make any and all transactions including deposits, withdrawals and rights of survivorship.
- 3.) Any owner(s), except the prime, who is designated as such on this Member Number, may be removed or added to the subaccount(s) of this Member Number, by any one of the other owner(s) provided such change is received and accepted by GCU.
- 4.) GCU may transfer any funds on deposit in any subaccount(s) designated by this Member Number to reduce or pay in full any outstanding balance(s) any owner may owe to GCU whether or not owed under this Member Number.
- 5.) Any owner may pledge all or part of the funds held in any subaccount(s) designated by this Member Number as collateral security to any obligation(s) incurred by such owner either as maker, co-maker, and guarantor with GCU.
- 6.) Items received by GCU for deposit are provisionally credited subject to final payment and receipt of proceeds of final payment in cash or solvent credits by GCU at its office.
- 7.) GCU may amend this agreement by sending written notice to any joint owner at the mailing address in use by GCU at the time of such notice. The amendment shall take affect thirty (30) days after mailing.
